Based on criteria for maintaining WHO recognition and annual review of NIC performance during the 2014/2015 influenza season, we are pleased to inform you that the WHO-recognized NIC in Republic of Moldova headed by Dr Constantin Spinu at the National Influenza Center in your country performs well against these criteria and maintains WHO recognition.

The Regional Office annually sends a letter to those Member States with a WHO-recognized National Influenza Centre (NIC) to state whether they have met the criteria for extension of WHO-recognition, as described in the letter sent by the Regional Director in May 2011.

By means of this annual assessment, we aim to support countries to maintain the National Influenza Centres in the WHO European Region as they play a key role in influenza surveillance at the national level and participate in regional and global surveillance, through the Global Influenza Surveillance and Response System (GISRS), by contributing to the implementation of the Pandemic Influenza Preparedness (PIP) Framework, and participating in the joint European Centre for Disease Prevention and Control/WHO Regional Office for Europe Flu News Europe weekly influenza update. The data generated by the NIC are critical to understanding the timing and spread of influenza epidemics and the contribution of different viruses to morbidity and mortality. Influenza viruses shared by the NIC with the GISRS contribute to the twice annual selection of viruses for seasonal influenza vaccines, monitoring susceptibility to antiviral drugs, detection of emerging influenza viruses and assessment of the risk posed by novel influenza viruses with pandemic potential. According to their Terms of Reference, NICs are required to send shipments of representative seasonal influenza viruses to the WHO Collaborating Centres for Reference and Research on Influenza (WHO CC), and comply with the Standard Material Transfer Agreement 1 of the PIP Framework for sharing of influenza viruses and access to vaccines and other benefits by shipping, within one week, clinical specimens and/or viruses that cannot be readily identified with diagnostic reagents provided through the WHO GISRS to a WHO CC or H5 Reference Laboratory of their choice. We kindly request you to continue to support these shipments.

WHO counts on your support to the NIC to maintain its WHO-recognition status and fulfil NIC Terms of Reference as well as strengthening virological influenza surveillance and to enhance NIC capacities to respond to emerging influenza viruses such as avian influenza A(H7N9) virus.
